**A RESOLUTION OF MILLER COUNTY, GA, SETTING AND ADOPTING MILLAGE RATES FOR BOTH UNINCORPORATED AND INCORPORATED AREAS OF THE COUNTY FOR THE FISCAL YEAR 2019-2020; AND ESTABLISHING AN EFFECTIVE DATE.**

**NOW, THEREFORE, BE IT RESOLVED** by the County Commission of the County of Miller, State of Georgia, as follows:

That Resolution #19-1003 hereby levies on taxable real and personal property in the unincorporated and incorporated areas of the County, the following Millage Rates to be distributed independently to the Miller County Board of Commissioners:

Less Sales Tax Credit	<u>1.9200</u>
Less Insurance Premium Tax Credit	-0-

Insurance Premium Tax Credit based on \$266,820.00 LESS service for roads in the unincorporated county of \$266,820.00 for a new credit of \$0.00.

Total Library Millage	<u>0.005480</u>






**BE IT FURTHER RESOLVED** that all Resolutions or Ordinances in conflict with this Resolution are hereby repealed.


